- The reviewed area consists entirely of uplands.
- Unable to confirm the presence of waters in 33 CFR part 328(a)(1, 2, or 4-7).
- Headquarters declined to approve jurisdiction on the basis of 33 CFR part 328.3(a)(3).
- The Corps has made a case-specific determination that the following waters present on the site are not Waters of the United States:
 - Waste treatment systems, including treatment ponds or lagoons, pursuant to 33 CFR part 328.3.

 - Non-tidal drainage or irrigation ditches excavated on dry land. Explain rationale:
 - Other (explain): The Borrow Pit and Wetland 1 are a result of past gravel/sand operations. The portions surveyed within the proposed ROW exhibit all three mandatory wetland criteria. The Borrow Pit and Wetland 1 are manmade and hydrologically isolated from other waters of the United States. The Borrow Pit and Wetland 1 are both located outside the mapped 100-year floodplain. The Borrow Pit encompasses approximately 0.194 acre within the proposed ROW and Wetland 1 encompasses approximately 0.055 acre within the proposed ROW.
